The CHARTER of the International Association for

1. GENERAL REGULATIONS

1.1. "The International Association for Bloggers", also known as the IAB, is based on the membership public association, established on the initiative of bloggers, on the basis of mutuality of interests for the realization of the common objectives, as described in the present Charter.

1.2. The IAB is carrying out its activities in accordance with the European Convention on the protection of human rights and fundamental freedoms, by the present Statute and is guided in its activities with generally accepted international principles, norms and etalons.

1.3. The IAB program is based on the voluntariness, equality, self-government and legitimacy.

1.4. The IAB may enter into unions (associations) of public large formations.

1.5. The IAB there is since the inception of the common assembly.

1.6. The IAB at this stage does not have a circular print, stamp, logo and letterheads with its name, but reserves the right to register in the future in any country as a legal official. After registration the IRB will have a circular print, stamp, logo and letterheads with their name to be announced to the registration body envisions.

1.7 The IAB program is transparent, and the information on the program and its constituent documents is available to all.

1.8. The meaning of the Association is to combine intellectual pool of mankind, to identify conceptual ideas and positive thinking through communication, which will allow bloggers affect the various spheres of life in any country in the world with the universal human values and priorities; as well as in the systematization, adaptation, the conservation and protection of the rights of all innovations, including, useful for the work of the IAB.

1.9. The region of the IAB's activity: the worldwide.

1.9.1 The location of a permanent governing body of the IAB: Germany.

2. THE STATUTERY GOALS OF THE IAB

2.1. The purposes of association are:

- promoting the level of information culture of the members of the IAB;

- the holding of independent public examinations in the bills, legal acts of organs of the state and municipal authorities, as well as their activities as a whole in any country;

- introduction and protection of rights and legitimate interests of its members, as well as other citizens in the organs of the state power, bodies of local self-government and public associations of any country;

- in order to achieve the implementation of the policy in the field of creation of an electronic government;

- Full implementation of the powers provided for by laws of the international associations;

- the statement with the initiatives on all the issues public life;

- extend proposals in the state authorities and local self-government of any country;

- to participate in the discussion resonance materials, emerging in the media with a view to develop and extend proposals relating to development of the various PR-actions for the settlement of international, interethnic, ethnic, religious and other relations in society.

2.2. The IAB independently determines the focus of its activities, a strategy for cultural, ethic, and aesthetic, economic, technological and social development.

2.3. The IAB is entitled to represent and protect its rights and the legitimate interests of its members, as well as of other citizens in the organs of the state authorities, local self-government bodies and public associations of any country.

2.4. Physical persons and legal officials may participate in the activities of the IAB through the provision of the donated property, as well as through the provision of institutional and other forms of assistance to support the implementation of the IAB program in its statutory activity.

2.5. The Association has to:

- to comply with international law and the generally recognized principles and norms of international law relating to the scope of its activities, as well as the norms provided by its constituent instruments;

- in the event registration of the IAB is obliged to keep body, receiving a decision on the state registration, the continuation of its activities with a real location of the permanent governing body, its name and the data on leaders;

- to allow representatives of authority, receiving a decision on the state registration, the activities undertaken by the Association;

to assist with the decision-making body of the state registration and to familiarize with the work of the IAB for compliance with statutory goals and the observance of the rule of law;
to publish an annual report on the activities of the IAB;

3. ASSEST OF ASSOCIATION, THE REGULATION OF THE MEMBERSHIP

3.1. Be in the asset or a member of association may be all positively minded and talented bloggers of any countries that have attained 18 years of age, as well as public organizations in the status of legal officials.

3.2. The reception in asset of the IAB is the statement of joining person.

3.3. The asset have equal rights:

- to receive information on the activities of the IAB;

- to contribute to the higher Council of the IAB and officials of the IAB any proposals for the improvement of the activities of the Association;

- to participate in its activities;

- to elect and be elected in its elected bodies;

3.4. Responsibilities:

- to abide by the Charter of the Association;

- to promote/contribute to its work;

- to refrain from any actions (inaction), likely to harm of the IAB;

- to carry out decisions of the General Assembly and the Supreme Council of the IAB, adopted in the framework of their jurisdiction.

3.5. To terminate the membership in the IAB can be by way of a petition to the Supreme Council of the IAB and the subsequent decisions of the Supreme Council.

3.6. Any member of the IAB is deemed to have separated from the association with the date of the submission of the application and follow-up the resolution.

3.7. The member of the IAB may be excluded for the violation of the Charter, as well on the basis of detected in the information network extremist rhetoric, and incitement to hatred, boomer discord, manifestations of racist, chauvinist, anti-Semitic ideology, unprintable or/and obscene vocabulary and so on.

3.8. The exclusion of members shall be the decision of the General Assembly of the Council of the IAB a simple majority with the follow-up assessments for the reason.

4. HOW TO MANAGE THE ASSOCIATION

4.1. The highest governing body for the IAB is the General Assembly of the members of the Superior Council of the IAB program. The General Assembly of the members of the Supreme Council shall be convened as necessary, but at least two times a year. The General Assembly is entitled, if it is present in more than half the members of the Higher Council of the IAB. Decisions are taken by an open ballot.

4.2. An extraordinary General Assembly of the IAB may be convened to address:

- the President of the IAB;

- program coordinator;

- 1-1/4 members of the Supreme Council;

- the audit commission;

- 1/4 of the members of an Asset of Association. 4.3. The General Meeting of the Council is entitled to make decisions on any matters of the IAB. 4.4. To the exclusive competence of the general meeting of the IAB program includes:

- the adoption of the Charter, to make additions and changes to their follow-up registration in accordance with the procedure established by law, the branch office or representation of the IAB;

- the election of the President, coordinator, crossing the audit commission of the IAB and early termination of their powers, the powers of the President of the IAB;

- consideration of the Supreme Council of the termination of office of the President of the Bar Association of starts after the statement by the president of the IAB;

- adoption of the annual plan and annual report;

- the adoption of decisions on the opening branch offices and missions of the IAB in any country;

- to decide on the issues of their reorganization and liquidation, with the subsequent creation of the Board of Elimination.

4.5. The Supreme Council is entitled, if it is present, more than half of the members of the Council. Decisions are taken by an open ballot.

4.6. The decision on all issues was adopted by the General Assembly of the Supreme Council by a simple majority vote of the members present at the meeting.

4.7. Decisions on matters relating to the reorganization and the elimination of, the proposed additions and changes to the Statute of the Association shall be adopted by a qualified majority of votes - not less than 2/3 majority vote of the total number of members present at the General Assemble of the IAB.

4.8. For the practical guidance of the IAB - the standing President of Association shall be elected at General Assembly by a simple majority of the Supreme Council.

4.9. The Supreme Council shall be appointed by the president of the IAB for the period up to 3 years from the number of activists in the number of established by the General Assembly.

4.10. The Supreme Council of the IAB may be re-elected as the expiration of the term of office for a further term. The question for the early termination of his term of office may be put to the consideration of the President of the Association and the General Assembly on top of the on-demand not less than 1/3 of the members of the IAB.

4.11. The Supreme Council of the IAB: - coordinates and organizes the work of Association, provides control of the implementation of the decisions of the General Assembly; - prepares questions for discussion at the General Assembly of the IAB; - annually informs registration body on the continuation of the activities of the IAB, indicating a valid location permanent governing body, its name and the data on its leaders; - has been receiving in the Asset of the IAB; - addresses any other issues relating to the exclusive competence of the General Assembly of the IAB.

4.12. Decisions shall be taken by a majority of votes of members of the Board of the Association that are present on the Session.

4.13. For direct guidance of the IAB General Assembly by a simple majority of the Supreme Council shall be elected by a standing President.

4.14. The President of the IAB proposes the candidate for the Coordinator of the Association who has to be elected by the General Assembly for the period up to 3 years.

4.15. The Coordinator of Association:

- who is accountable to the President of the IAB and the General Assembly of the Council, is responsible for the status of the IAB and the authority to deal with all the issues of the IAB, which is not attributed to the exclusive competence of the General Assembly of the IAB; there is no prove and on behalf of the Assessing of the IAB.

- there is no proxy and on behalf of the Association;

- introduces the IAB in all institutions, organizations and businesses in the territory of any country;

- oversees activities of Branch Offices and Missions of the IAB;

- provides control of the Branch Offices and Missions activities of the IAB

5. THE BOARD FOR INSPECTION AND MONITORING

5.1. Members of the audit commission may become members of the IAB program in the number of activists on any members of the superior council of the association by an open vote by simple majority vote.

5.2. The number of the members of the audit commission is dependent on the number of regions of the world, in which there were the members of the Association, and as the one to the one.

5.3. Control of the statutory activities of the IAB is crossing the commission of audit, elected the general assembly of the Supreme Council of the number of members of the Association for a period of two years.

5.4. The audit commission conducts statutory activities test of the IAB does not at least once a year.

5.5. Crossing the commission of audit is entitled to demand from officials of the IAB to provide all the necessary documents, reports, and personal explanations, including in writing state.

5.6. Crossing the audit commission represents the results of the tests for the General Assembly of the Supreme Council of the IAB.

6. THE PROCEDURE FOR REORGANIZATION AND ELIMINATION

6.1. The elimination of the IAB is the decision of the General Assembly of the Council, if this solution voted not less than 2/3 members.

6.2. The IAB can be eliminated or the decision of the General Assembly of the Supreme Council, if has voted for this decision is not less than 2/3 of presented members of the IAB, either by a Court decision. Liquidation or reorganization of the IAB is being carried out in the order, a certain international standards.

6.3. Documents and information on personal composition after the elimination of the IAB are deposited in accordance with the procedure established by law in the state archive, where the Association was registered.

6.4. The decision on the elimination of directed to the logging Association body.
